Remarks (if any):

(1) On 4 December 2019, a total of 9,325,375 share options were granted to certain eligible employees and directors, subject to their acceptance, pursuant to the Discretionary Long-Term Incentive Plan (please refer to the announcements dated 5 December 2019 and 8 January 2020). As at 31 January 2020, a total of 9,201,728 options have been accepted (the remaining 123,647 options were either declined or not accepted).

(2) On 25 March 2020, the Company granted to an eligible director, certain senior management and eligible employees of the Company a total of 49,720,699 share options pursuant to the terms of the Discretionary Long-Term Incentive Plan and a total of 16,080,138 restricted stock units pursuant to the Discretionary Restricted Stock Units Plan (please refer to the announcement dated 26 March 2020).

(3) On 2 March 2020, the Company granted a maximum of 184,996 locked-up shares in the Company in the form of voluntary shares and/or purchased shares, and a maximum 906,783 restricted stock units to certain eligible employees respectively pursuant to the terms of the Share-Based Compensation Plan and the People Bet Plan. On 20 March 2020, the Company announced to confirm that the final number of locked-up shares and restricted stock units granted by the Company is 107,610 locked-up shares and 830,468 restricted stock units after processing all final elections made by the Grantees and certain other deductions to final entitlements (please refer to the announcements dated 3 March and 20 March 2020).
